Time to (re)Consider Community Eligibility for the 2020-2021 School Year

The Community Eligibility Provision (CEP) is a powerful tool that allows high poverty schools to provide breakfast and lunch at no charge to all students. As New York schools finalize reopening plans for the 2020-2021 school year, CEP provides a valuable opportunity to support students and families, especially amid child food insecurity rising to unprecedented <u>rates</u>.

This is an important time for schools to take a fresh look at CEP for the 2020-2021 school year. The economic crisis - especially rising SNAP participation - will make more school districts and schools eligible to implement CEP. Schools should reexamine CEP as it could be a more financially viable option than before the COVID-19 crisis.

Important Dates:


- Eligibility for CEP is based on enrollment any time between April 1, 2020 and June 30, 2020, and 2019-2020 direct certification data.
- 2019-2020 direct certification data is only available to schools until August 3rd. Be sure to access/download the data before August 3rd, even if you are still considering CEP. Note: CEP eligibility and reimbursement are both based on this data.
- Applications for the 2020-2021 school year must be submitted to NYSED by August 31, 2020.

Time is running out for schools to apply!

The New York State Education Department (NYSED) is now accepting <u>applications</u> for school to participate in CEP for the 2020-2021 school year. NYSED's memo includes the application, reimbursement estimator tool, implementation guidance, list of schools eligible for CEP but not participating, and a list of schools currently participating in CEP. How CEP Benefits Students & Schools

In New York, over 1.7 million students attend a CEP school where school meals are offered at no charge to all students. CEP promotes equity by eliminating the out-of-pocket costs for families and by reducing stigma for students. Research has shown CEP safeguards children from food insecurity while also providing significant benefits for schools, including higher attendance rates.

As we look ahead to an uncertain school year, CEP can simplify and streamline student access to school meals in the following ways:

- CEP can support hunger relief efforts in your community.
- CEP can also support school nutrition departments as we work to find new ways to feed students. CEP streamlines school meals operations and makes it easier to implement meals in the classroom.
- CEP eliminates any concerns of unpaid school meal debt, helping families make ends meet at a time when many are facing lost jobs and reduced

wages.

 CEP can recover budget deficits in school nutrition programs. Providing school meals during closures related to COVID-19 came with a higher cost to schools, without any additional revenue for meals served. This program also helps school districts improve the financial viability of their meal programs.
